

## Greeley County Commissioner Minutes

January 09, 2024

The Greeley County Board of Commissioners convened in open and public session at 9:30 a.m. on the 9th day of January 2024 in the Boardroom, Greeley County Courthouse. Notice of the meeting was given by publication in the Cedar Valley News.

Answering present at Roll Call were Jordan Foltz, Joe Leslie, and Dennis Wadsworth. Also, present was County Attorney Cindy Bassett and County Clerk Mindy Grossart. Foltz stated a current copy of the Open Meetings Act is posted on the east wall of the boardroom and copies are available for the public if requested. Everyone present joined in the Pledge of Allegiance.

The meeting was then turned over to the County Clerk. Mindy Grossart, County Clerk acting as temporary Chairman asked for nominations for a 2024 County Board Chairman. Wadsworth moved to nominate Jordan Foltz as Chairman for 2024, second by Leslie. Roll Call Vote: All yes, motion carried. Jordan Foltz, Chairman asked for nominations for a Vice Chairman for 2024, Wadsworth nominated Joe Leslie for Vice Chairman for 2024, second by Foltz. Roll Call Vote: All yes, motion carried.

Leslie moved to set the county board meetings for the second and fourth Tuesday of every month at 9:30 a.m. unless otherwise advertised, second by Wadsworth. Roll Call Vote: All yes, motion carried. Motion by Leslie to designate Cedar Valley News as the Official County newspaper for 2024, second by Wadsworth. Roll Call Vote: All yes, motion carried. The Greeley County website ([www.greeleycounty.ne.gov](http://www.greeleycounty.ne.gov)) is declared as an official means of publication. Motion was made by Wadsworth, second by Leslie to approve the Board Appointments that Greeley County is associated with for 2024. Jordan: Mid Nebraska Individual Services, Region III Governing Board and Region 26, Joe: South Central Nebraska Agency on Aging, CCC Governing Advisory Council, and Loup Basin Regional Health Department, Dennis: Loup Central Landfill, Mid Plains Center for Behavioral Health and CNCS Housing Board. Roll Call Vote: All yes, motion carried.

Motion made by Leslie to appoint Josh Grummert, RLS as the Greeley County Surveyor, second by Wadsworth. Roll Call Vote: All yes, motion carried. Motion by Leslie to appoint Lance Harter as Highway Superintendent, second by Wadsworth. Roll Call Vote: All yes, motion carried. Motion by Leslie to appoint Trevor Nekoliczak as Planning & Zoning Administrator, second by Wadsworth. Roll Call Vote: All yes, motion carried. Motion made by Leslie to appoint Mark Haschke as Weed Superintendent, second by Wadsworth. Roll Call Vote: All yes, motion carried. Wadsworth moved to appoint Bill McManus as Emergency Manager, second by Leslie. Roll Call Vote: All yes, motion carried.

Next, the Board reviewed a resolution that was tabled during the 12/27/23 Board Meeting - Aaron Bos, Directory, Investment Services Nebraska CLASS. Wadsworth noted that in his opinion these types of investment agencies hurt local main street businesses. Wadsworth moved to not approve the Resolution for Nebraska Class, seconded by Leslie. Roll Call Vote: All yes, motion carried.

The following banks were reviewed as depositories for the year 2024: First National Bank, State Bank of Scotia, Citizen's State Bank, Homestead Bank, Henderson State Bank Cedar Rapids State Bank & NPAIT. Leslie moved to approve the 2024 depositories and to authorize the County Treasurer to invest idle funds appropriately second by Wadsworth. Roll Call Vote: All yes, motion carried.

The County Mileage reimbursement rate is set at \$0.67 according to Section 81-1176 effective January 1, 2024, subject to change if the government adjusts the rate. The Sheriff's Department is entitled to charge an additional 3¢ if serving papers.

A physician from the Howard County Medical Center will remain as the County Doctor. Motion made by Leslie to set the County burial policy as follows: the County will pay \$1,000.00 for cremation, second by Wadsworth. Roll Call Vote: All yes, motion carried. All resources such as savings and checking accounts, cash on hand, insurance, and any funeral benefit through Social Security or other sources are to be applied against the county funeral allowance.

All contractors will file proof of liability insurance with the County Clerk prior to any work being done.

The County Officials rate salary was set in Resolution dated December 28, 2021. County Assessor Deputy, Clerk Deputy, Treasurer Deputy are set at 75% and Sheriff Deputy 65%-85% of the official's salary. After a short discussion and review of comparable wages, motion by Wadsworth to approve 5% increases for all hourly employees, second by Leslie. Roll Call Vote: All yes, motion carried.

Wadsworth moved to approve the 2024 official holidays as set by State Statute 25-2221, second by Leslie. Roll Call Vote: All yes, motion carried. All days declared by law or proclamation of the President &/or Governor to be a holiday. Motion made by Wadsworth to approve Courthouse Hours 8-4, second by Leslie. Roll Call Vote: All yes, motion carried.

Leslie moved to enter BOE at 10:47 a.m., second by Wadsworth. Roll Call Vote: All yes, motion carried. Gerri Behnk, Assessor presented Tax list correction #1273: Curtis Kaslon property ID 390157900-RE original amount \$69,745, homestead credit \$651.80 total tax \$126.04 corrected amount \$69,745, homestead credit \$814.74, total tax 0.00. January 23, 2024

The Greeley County Board of Commissioners convened in open and public session at 9:30 a.m. on the 23rd day of January 2024 in the Assembly Room, Greeley County Courthouse. Notice of the meeting was given by publication in the Greeley Citizen.

Answering present at Roll Call were Jordan Foltz, Joe Leslie, and Dennis Wadsworth. Also, present were County Attorney Cindy Bassett and County Clerk Mindy Grossart. Chairman Foltz stated a current copy of the Open Meetings Act is posted on the east wall of the County Boardroom and copies were available for the public if requested. Everyone present joined in the Pledge of Allegiance.

Chairman Foltz stated Governor Jim Pillen announced that Nebraska is in a state of emergency after the snowstorm that started on January 12, 2024. The Greeley County Board of Commissioners signed a Disaster Declaration for the snowstorm with blowing and drifting snow that started on January 12, 2024.

Motion was made by Leslie to waive the reading and approve the county board minutes from the January 9, 2024, meeting, second by Wadsworth. Roll Call Vote: All yes, motion carried.

County payroll and vendor claims were reviewed by the board. Motion made by Leslie to approve payroll and claims, second by Wadsworth. Roll Call Vote: Leslie yes, Wadsworth yes, Foltz abstain, motion carried.

Bill Hamer, Hamer Farms LLC applied for a Permit to Cross Under County Roadway with an electric line for an irrigation well. He plans to cross in the SE ¼ 13-17-12 to the SW ¼ 18-17-11. Leslie moved to approve the Permit to Cross, seconded by Wadsworth. Roll Call Vote: All yes, motion carried.

Sheriff Paul Deaver met with the Board and gave some updates on his office. He advised the Board that Ted Scott is no longer employed with Greeley County. Sheriff Deaver also stated the construction in his office should be complete soon.

Public Comment: Matthew Jones, Nextera, stated they were in the area for check presentations and wanted to stop and give an update. Matthew explained they want to continue to work with emergency services in the area as they continue to prepare for the project. He indicated that they would design and build the switch yard and then will turn it over to NPPD. Matthew also said they continue to engineer the design and development of the roads to get to the turbine sites.

Ken Ryan, Planning & Zoning Chairman had some personnel questions. Wadsworth moved to enter executive session at 9:47 a.m. for the purpose of discussing personnel, second by Leslie. The County Board, Cindy Bassett, County Attorney and Ken Ryan Planning & Zoning Chairman were present for the executive session. Motion made by Leslie to exit executive session at 9:59 a.m., second by Wadsworth. Roll Call Vote: All yes, motion carried.

Next, Chairman Foltz opened sealed bids for Carpet and Tile installation and removal and disposal of old materials. Jim Martin: 1. \$87,500 for the advertised bid. 2. \$92,500 higher quality carpet with the following terms: Deposit \$6,500 required before the carpet is ordered, additional \$20,000 required when the carpet is delivered, additional \$30,000 due when the project is 50% complete, balance due upon completion. Kuszak Hardware & Variety LLC \$98,822.60, with the following terms: deposit required to order materials, payment in

full after completion. Leslie moved to approve the bid from Kuszak Hardware & Variety LLC, motion failed for lack of a second. After discussion, Foltz moved to table the carpet bid decision until February 13, 2024, at 10:00 a.m., seconded by Wadsworth. The Board has additional questions they would like to ask both bidders and wanted additional time to research grant money guidelines to determine if carpet would qualify as one of the uses allowed. He would like the Board to consider using the interest money to protect the taxpayers and to use it for decommissioning and roads.
